Fish Forever By empowering communities with local control over their natural resources, Fish Forever seeks to inspire communities, and nations, to sustainably manage coastal fisheries. Global demand for fish has pushed the oceans to their limits. We believe that the adoption of rights-based fishery management systems will help turnaround the oceanic crisis, resulting in transformative impact for both people and nature. Our innovative coastal fisheries resource management solution marries managed access of fisheries with marine reserves. We envision a future in which 100% of coastal fisheries are sustainably managed. And, we are committed to working toward this ambition until it becomes reality. Achievements include: In 2017, Rare undertook a comprehensive program review of 41 project sites in Brazil, Indonesia and the Philippines encompassing 260 communities, 35,000 fishers and 570,000 people. The Fish Forever program has resulted in 60 managed access and reserve areas representing 600,000 hectares of coastal waters and 27,000 hectares of fully protected reserves. At 97% of the sites, the amount of fish remained stable or increased. Coral cover remained stable or increased inside reserves at 80% of the sites. 35 legally recognized decision-making bodies strengthened and/or established to oversee managed access waters, reserves, and fishing activities.

Pride Campaigns Rare Pride campaigns train local conservationists to inspire people to take pride in the species and habitats that make their communities unique, while also promoting alternatives to environmentally destructive practices. After 40 years and over 400 campaigns, Rare Pride has reached over 10 million people. And conservation is about people, their attitudes and behaviors. When you change these, you can change the world. Human behavior is the root cause of every major conservation and development challenge. Therefore, changing how people behave is the single most important thing we can do to ensure nature's survival. Pride, it turns out, is a universal motivator. Pride campaigns use proven marketing tools, like persuasive messages, campaign mascots, billboards, public events and radio shows, to promote conservation behaviors. Today, Rare Pride campaigns support innovative solutions for sustainable watersheds, coastal fisheries, organic agriculture, and more. Achievements include: Pride Campaigns launched in previous years reported a 70% decrease in illegal hunting of migratory birds and a 500% increase in price for farmers trained in producing eco-friendly honey compared to selling regular honey. China Pride Unsustainable agricultural practices remain one of the greatest threats to ecosystems and biodiversity, they also endanger the stability of food supplies and essential commodities and are a listed cause of climate change. But, there are solutions. We are working in China with local farmers on organic crop cultivation and with partners around the globe to identify the best locally-led sustainable agriculture practices through the Farming for Biodiversity initiative. Rare's sustainable agriculture program evolved from an organic farming pilot project in China's Tian-e-Zhou (TEZ) Oxbow Nature Reserve, a wetland in the Yangtze basin in Hubei Province, adjacent to the Shishou Elk and Finless Porpoise Nature Reserves. On roughly 100 acres of land, the farmers planted corn, cotton and soybean, following organic farming methods, including the use of organic fertilizer and less harmful methods for protecting cotton seedlings from pests: no artificial fertilizers, chemical pesticides or herbicides present. The farmers also took part in poly-cropping, a method of rotating crops that aids in nitrogen fixation and increases soil quality ahead of future cultivation. Ultimately, the farmers harvested 10,000 kg of cotton, 60,000 kg of soya and 27,500 kg of corn, all of which were certified as in-transition organic crops. Following this first successful organic harvest in Tian-e-Zhou, Rare is using the lessons learned from the farming pilot to replicate sustainable agriculture in more Chinese communities. As farmers see organic farming and its benefits in action, more can make the switch to organic farming and secure a sustainable, safe, and profitable future.

Form 990, Part III, Line 4c:

Watershed Conservation Program The Watershed Conservation Program in Colombia aims to manage and protect local watersheds, which is critical to the country's sustainable development. And, with the brokering of peace between the FARC and the Colombian government, this is an opportune time to inspire a conservation ethic. For its size, Colombia is the most biodiverse country in the world. With more than 54,000 registered species, Colombia shares with Brazil the first place in the megadiverse nations of the planet and ranks first in number of amphibian and bird species. Colombia is also home to half of the planet's existing cloud forests, which produce more fresh water than almost any other environment on earth. Rare seeks to inspire Colombians to protect Andean forests to ensure water quality and reliability, and maintain the natural function of water-regulating ecosystems. Achievements include: Since the launch of the program in Colombia in 2016, a total of 36 Watershed Conservation contracts have been signed, placing under protection and improved management 1,811 hectares of water-regulating forest in 14 watersheds in Valle del Cauca. These sites were selected for being priority areas for water regulation as well as key areas for biodiversity conservation. The total cost of the benefits packages at 32 farms is US\$ 1,441.6 /ha/year (US\$ 45 on average per contract).
