COMMUNITY ENGAGEMENT GRANTS AND INTERNAL PROGRAMS ARE VOLUNTARY CONTRIBUTIONS AND EFFORTS TO FOSTER A SPIRIT OF PHILANTHROPY AND HONOR THE TRADITION OF VOLUNTEERISM IN OUR COMMUNITY. EXAMPLES INCLUDE LECTURES, GIVE LOCAL PIEDMONT AND HOLIDAY KINDNESS. REGIONAL POPULATION HEALTH GRANTS SUPPORT INITIATIVES DESIGNED TO ENHANCE OR CHANGE SYSTEMS THAT IMPACT THE HEALTH OUTCOMES OF A BROAD POPULATION. RESOURCE CENTER: FISCAL YEAR 2017 MARKED THE FIRST FULL YEAR OF THE FOUNDATION'S CONTRACT WITH CENTER FOR NONPROFIT EXCELLENCE (CNE) TO PROVIDE TRAINING, TECHNICAL ASSISTANCE, AND RESOURCES TO NONPROFITS IN THE FOUNDATION'S FOOTPRINT AT THE PATH RESOURCE CENTER. THE CONTRACT, AS WELL AS EDUCATIONAL MATERIALS FOR TRAINING, EXPENSES FOR THE OPERATION OF THE PATH RESOURCE CENTER OFFICE SPACE, AND IT SUPPORT SERVICES FOR PHONES AND COMPUTERS TOTALED \$190,946 IN FY2017. BETWEEN OCTOBER 1, 2016 AND SEPTEMBER 30, 2017, THE PATH RESOURCE CENTER PROVIDED 11 WORKSHOPS TO 258 ATTENDEES, 1 ADVANCED BOARD TRAINING TO 20 ATTENDEES, 1 BOOK CLUB FOR 7 ATTENDEES, 2 EXECUTIVE LEADERSHIP CIRCLES TO 10 PROFESSIONALS MONTHLY. CNE PROVIDED TECHNICAL ASSISTANCE TO OVER 150 NONPROFIT PROFESSIONALS DURING THE YEAR. THIS AMOUNTS TO OVER 675 NONPROFIT PROFESSIONALS RECEIVING RESOURCES FROM THE PATH RESOURCE CENTER. VOLUNTEER CENTER: THE END OF FISCAL YEAR 2017 MARKED 10 FULL MONTHS OF OPERATION OF OUR LIVE VOLUNTEER MATCHING SITE, LETSVOLUNTEER.ORG. DURING THAT TIME 620 COMMUNITY MEMBERS REGISTERED ON OUR SITE IN RESPONSE TO 251 OPPORTUNITIES POSTED FROM AREA NON-PROFITS. THIS COMMUNITY VOLUNTEER ENGAGEMENT EQUATED TO A TOTAL OF 1502 HOURS DONATED DURING THAT TIME, KEEPING IN MIND NOT ALL VOLUNTEER HOURS ARE REPORTED. OUR YEARLY CONTRACT INVESTMENT WITH GALAXY DIGITAL, FOR THE LICENSING TO HOST THIS SOFTWARE IS \$2,250.
