In 2016-2017, Mission Eurasia's SWW students and other national Christian leaders distributed 676,000 copies of the following Scripture pieces throughout Eurasia: Evangelistic calendars, the Gospel of Luke, The Greatest Stories of Hope, Hope Magazine, New Testaments, Noah's Ark Magazine, and the Gospel of John. In addition, Mission Eurasia is helping to cultivate a Next Generation of Christian authors within Eurasia through its National Christian Authors Series. Through this program, Mission Eurasia oversees the publication and distribution of titles that enable young leaders to present solutions to the challenges facing the evangelical church and society in Eurasia.
