Total value of food provided (estimated) : \$ 138,634 which includes \$ 20,521 of food purchased with our cash donations and \$ 118,112 of in-kind donations from food banks, retailers, and others. This food was provided to 2,612 households containing 7,677 individuals.

We received no revenue from this activity.

Providing new and used clothing and housewares to the poor. Total value of items distributed (estimated) : \$ 67,900. All of these distributions were from in-kind donations. These were distributed to 3,839 individuals. We received no revenue for this activity.

Providing emergency financial assistance to the poor, for such items as payments to avoid utility shut-off, payments to avoid rental eviction, and transportation, medical, or small-bills assistance. This assistance was provided to 519 individuals. All funds for this activity come from donations provided by our Church congregation. No revenue was received for this activity.

Part I Line 2: As we are an organization dedicated to serving the poor, all of our grants (both monetary and in-kind) are made to individuals who demonstrate financial need, primarily in compliance with income levels suggested by local food banks and similar organizations. Clients must also provide evidence of residence as, per our by-laws, we serve those in our Parish area. Monetary grants (emergency financial assistance) are provided only in response to utility shut-off notices, rental eviction notices, and similar situations. Any such monetary grants are paid directly to the utility, landlord, transportation, or medical provider, etc. - we do not give cash or checks to clients, providing a safeguard that funds are used as intended. All our records of assistance are maintained as paper records at our facility, are kept on forms recommended by our local food banks or other providers, and are updated at each visit by a client. Our practices significantly limit the amount of assistance any client can receive as well as strictly limiting the times they can re-apply for assistance. Therefore, no individual received aid in excess of \$2000 in total (monetary and in-kind) within a calendar year.
