The objective of AARDA's educational programming is to improve early and correct diagnosis of all autoimmune diseases. The scientific meetings provide opportunities for valuable cross-fertilization of research information. AARDA continues to conduct public awareness campaigns and publish patient education information and a quarterly layfriendly newsletter. It sponsors an award-winning Web site, maintains social networking sites, and provides a 24-hour toll-free request line. AARDA provides free educational brochures and newsletters to numerous health-centered meetings and events. AARDA continues to offer an educational curriculum targeting grade-school-age children, with the objective of educating the students and their families on the "family connection" of autoimmune diseases, thus helping them to understand that multiple autoimmune diseases can run in families.

AARDA combined advocacy and awareness in sponsoring ads on behalf of patients concerning the Prescription Drug User Fee Act (PDUFA) and the accessing to specialists by autoimmune patients. By invitation, AARDA provided a speaker at the European Parliament of the European Union concerning establishing autoimmune disease as a disease category. AARDA provided interviews and information for news media and had major advertisements and articles (or acknowledgements) in local and national publications. Membership was expanded in the Autoimmune Partners Council which brings together the nonprofit, institutional, and corporate groups having a mutual interest in autoimmune disease and patients.

AARDA continues its focus on autoimmune advocacy and education through Capitol Hill briefings concerning issues surrounding patient care, such as, access to medicines, patient and family measures of coping with autoimmune disease, and other topics pertinent to autoimmune disease.
