IN FY17, UNITED COMMUNITY ACTION PARTNERSHIP (UCAP) PROVIDED HEAD START SERVICES TO 422 CHILDREN AND THEIR FAMILIES, WHILE EARLY HEAD START SERVED 115 CHILDREN AND FAMILIES.
