Eighty-one MARAMA agency staff members were provided support to attend 17 national and regional conferences, meetings, and training courses. These included the following: 15th Annual CMAS Conference, IMPROVE Steering Committee Meeting, Asbestos NESHAP Inspection Safety Procedures, Principles and Practices of Air Pollution, RSL Modeling Conference (BEN/ABEL), NACAA Monitoring Steering Committee Meeting, Financial Analysis and Ability to Pay Training Course, Technical Exchange Forum for PM Site Operators, Health Effects Institute Annual Conference, AWMA Annual Conference, Next Generation Data Analysis, EPA 2017 International Emissions Inventory Conference, Region III Air Directors Meeting, Joint Training Committee Meeting, AAPCA Fall Business Meeting, NACAA Fall Membership Meeting, and the RSL Modelers Workshop.

Improving and Updating the Regional Emissions Inventory: In FY 2017, MARAMA helped member agencies work together and collaborate with nearby states by updating the 2011 regional inventory of air pollutant emissions to include estimated emissions for 2020. To estimate future emissions, MARAMA projected 2011 emissions to 2020 using its Excel-based tool to develop some of the growth factors for 2020 and

interpolation between 2017 and 2023 factors for the rest.

MARAMA also responded to the US Environmental Protection Agency's (USEPA) release of its 2023 inventory with comments from its member agencies regarding emission controls, new units, and source closures.

Additionally in FY 2017, MARAMA continued developing the cloud-based Emissions Modeling Framework (EMF) to house the emissions inventory, identify and correct issues with the data, create specific files for special projects, apply growth and control factors, and transmit data to regional modeling centers. MARAMA provided guidance to member state staff to help member agencies use the tool to analyze emissions.

MARAMA participated in an inter-regional workgroup to improve emissions data for Electricity Generating Units (EGU). The workgroup has developed a tool to project EGU emissions that integrates data from a number of nationally recognized sources, including the Energy Information Agency (EIA), state agency permitting information concerning unit controls and operation, USEPA Clean Air Markets Division (CAMD) hourly EGU emissions data, and North American Energy Reliability Corporation (NERC) peak power estimates.

MARAMA organized frequent conference calls and webinars to coordinate the preparation of the inventory and provide organized feedback to EPA on issues related to emissions, particularly with respect to on-road mobile sources and oil and gas operations. MARAMA participated on several national work groups to improve the state-of-the-art for emissions inventories.
