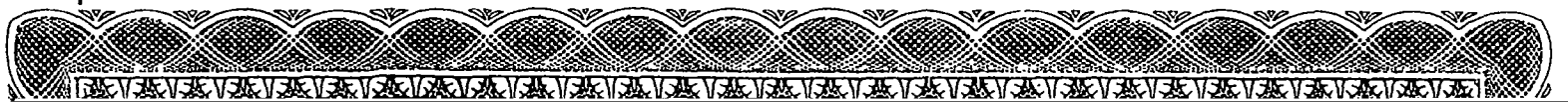

Articles of Incorporation and Plan of Consolidation

This plan of Consolidation is entered into this September 14, 2017 by and between Fargo Little League Baseball, a North Dakota nonprofit corporation, and Fargo Babe Ruth Baseball, a North Dakota nonprofit corporation.

Recitals

- A. Both corporations are nonprofit corporations that promote and support youth baseball in Fargo, North Dakota and its surrounding areas.
- B. Both corporations desire to consolidate corporations to improve operations, provide better resources, expand opportunities for participation, enhance player development, and other valuable goals and purposes to carry out a "kids-first" mission.

Agreement

Now therefore, in accordance with the provisions of NDCC 10-33-85 through 10-33-91, both corporations hereby agree that both corporations shall consolidate under the terms and conditions set forth in this plan:

1. Consolidation. As of September 14, 2017 Fargo Babe Ruth and Fargo Little League have come to an agreement to consolidate into one organization. This Organization is to be called Fargo Youth Baseball.
2. Effective Time of Consolidation. As of October 1, 2017 Fargo Youth Baseball will be its own nonprofit corporation operating under a consolidation certificate from the ND Secretary of State, and will subsequently apply for a new Federal EIN number and a new 501c3 status. A new Board of Directors will be elected from the currently existing boards and operate according to a new set of bylaws to be approved by the new board, once established.
3. Effect of Consolidation. As of October 1, 2017, Fargo Youth Baseball shall succeed to, without other transfer, and shall possess and enjoy, all the rights, privileges, immunities, powers of a public and private nature, and shall be subject to all restrictions, disabilities and duties of each corporation and all its properties. The objective of Fargo Youth Baseball is to implant firmly in the children of the community the ideals of good sportsmanship, honesty, loyalty, courage and respect for authority, so that they may be well adjusted, stronger and happier children and grow to be good, decent, healthy, and trustworthy citizens. To achieve this objective, FYB will provide a supervised program under the Rules and Regulations of selected chartered programs. FYB will function from two board-approved principles: no personal agendas and kids first.
4. Approval. This plan is subject to approval by the Boards of Directors of Fargo Babe Ruth and Fargo Little League in accordance with the provisions of NDCC Ch. 10-33. After such approval, and subject to the conditions set forth in this plan, will be signed, verified, and delivered to the Secretary of State for the State of North Dakota.
