COMMUNITY HEALTH FUND Impact Alamance provides a limited number of grant opportunities to meet community health needs outside of its priority areas. The goal of the community health fund is to partner with non-profit agencies to foster creativity and innovation through one-time awards to implement or expand new ideas. In FY 17, these investments were designed to further the priorities identified in the community health needs assessment. Investments focused on income and economic development through a new community engagement initiative with a local non-profit. One hundred thousand dollars went to the local Health Department to further access to care for teens in Alamance County. These funds will design a teen friendly clinic with a goal of decreasing teen pregnancy.

HEALTHY COMMUNITY A healthy community is one where residents are physically and emotionally healthy, and able to energetically contribute to their community's civic life and economic wellbeing. That's the vision we have for Alamance County. We are focused on creating an environment where businesses, government agencies, community organizations, and neighbors, work together to create a healthier community. We believe that creating a healthier community is a mission that no single person, organization or agency can do alone. We must all work together. In fiscal year 17, Impact Alamance invested nearly half a million dollars to support that common vision and our community. We are supporting a community effort to help community leaders, businesses and organizations, and citizens, come together around a common vision to improve outcomes for our kids. We're partnering with national leaders StriveTogether, and are working to see that all children, regardless of their ZIP code, have an equal opportunity for success from cradle to career. In Fiscal Year 17, a local organization was launched and staff hired to support this effort. Additionally, the first work started in the community to ensure that all children are born healthy and get the strong foundation they need to be ready for school, and life. Impact Alamance also invested in professional development opportunities for teachers in the Alamance Burlington School System and a targeted capacity building initiative for our local non-profit organizations.
