Among these services is LanguageLinc, a professional interpretation and translation service, a Tax Preparation Program, which provides free tax preparation and filing services, the Navigator Program, which provides assistance to individuals in seeking health insurance and connecting to primary care, and a Fan Program, which distributes free fans to households in the summer and provides education pertaining to home energy efficiency. Just to name a few outcomes achieved in fiscal year 2017, 787 individuals were provided tax preparation and filing services and 479 individuals enrolled in health insurance plans and learned how to use coverage to their financial benefit.

Basic Needs Individuals cannot move toward greater economic stability if their basic needs such as food, clothing, and housing are not met. Just some basic needs services provided by Community Action include an Incentive Room, where participants can use points they've earned in their program in exchange for household and personal hygiene supplies, emergency assistance with rent, utilities, and deposits, and free hot and nutritious evening meals at The Gathering Place. In fiscal year 2017, 3,538 individuals received financial assistance with rent and utilities and 27,535 meals were served at The Gathering Place.

These include a Representative Payee Program, which oversees the responsible use of benefit payments for those receiving SSI or SSDI and are required to have a payee, Tenant Support Services, which provides education and mediation geared toward eviction prevention, Lincoln Community Response, which provides a host of supports designed to prevent entry into the child welfare system, Displaced Tenants Program, which provides assistance to Lincoln tenants who have been displaced after their homes have been red-tagged, Youth Eviction Prevention Program, which supports at-risk youth in maintaining stable housing, Homeless Voucher Program, which works in partnership with the Lincoln Housing Authority to support housing stability of households with a Section 8 housing voucher, and Supportive Housing Program, which transitions families experiencing homelessness into permanent housing and provides case management to support their movement toward self-sufficiency for two years.

HousingThrough its subsidiary non-profit, Lincoln Action Program Housing Development Corporation (LAPHDC), Community Action provides safe, decent, and affordable housing through two low-income financed rental developments in Lincoln and Wahoo. Through its Weatherization Program, Community Action identifies areas of energy inefficiency in homes and provides services (which may include furnace tune-ups, window/door caulking, and insulation) to remediate. In fiscal year 2017, 64 individuals resided in LAPHDC housing units, and 43 homes received Weatherization services to improve energy efficiency and decrease utility burdens.

The Human Resource Director completes a spreadsheet with current employee data, current rates of pay, rates of pay compared to this statistical study and other Community Action Partnership agencies in the area. A salary range is established for each position by the Human Resource Director and reviewed by the Executive Director. All salary ranges are reviewed periodically by the Human Resources Committee and updated by the Human Resource Director. General results are reported to the Board.
