With a staff of 29 (70% Veterans) and a volunteer Board of 8 (65% Veterans), the VIC strives to end homelessness and support our Veterans to prevent homelessness. In FY2017, the VIC CEO continued on the National Coalition for Homeless Veterans (NCHV) Board of Directors, became co-chair for the Community Veterans Engagement Board, the VIC received the Behavioral Health Support Division Star Award and was notified that the VIC had received a 3 year grant for the SSVF Program, and 3 separate 3 year Grants for the GPD Program for the next fiscal year.
