Our Residency program fosters outreach amongst our residents, and in their first year they performed over 600 blood pressure screenings at events. Our Pediatric Diabetes Family Fun Run helped raise awareness and provide education to 220 people in our community. We will continue our aggressive outreach efforts to help educate our patients about the various risk factors associated with all the identified needs. The health system has added new access points in the forms of urgent care and primary care practices so patients have greater access to physicians. We are strengthening our relationships with our local health departments and identifying potential collaborations with community stakeholders. Cape Fear Valley Health System is constantly evolving to meet the needs of the communities we serve. We have already begun the next steps for our next Community Needs Assessment to learn if we are heading in the right direction. Our vision is to improve the quality of life of every life we touch.
