Each candidate must submit a scholarship application, evidence of acceptance or attendance, and the bill for tuition from their respective schools. Scholarship recipients are chosen from the pool of candidates by a committee consisting of Human Resources and Executive management. The amounts of individual scholarship awards are determined based on the individual's cost of tuition and the number of candidates applying for each scholarship. Also provided is tuition reimbursement for sighted, blind and visually-impaired employees. Employees wishing to receive reimbursement must complete a request form detailing the courses they wish to take and how those courses contribute to their current position within the company. These forms are reviewed and approved by the immediate supervisor and the HUMAN RESOURCES MANAGERS.
