institutions, governmental units, associations, societies, organizations or any other groups with an interest in the Corporation and

furtherance of its objectives shall be eligible for membership as a Sustaining Member upon payment of specified dues. Each Sustaining

Member shall be eligible for a single vote but shall not have the privilege of being an officer of the corporation. (d) Public or private

institutional libraries as may be recognized by the Board of Directors shall be eligible to become Library Members, upon payment of

specified dues, for the purposes of receiving all Institute publications. Library Members shall have no voting privileges or be able to hold

office in the Corporation. (e) A person who is current and active in a diploma or degree seeking with an institution of higher learning is

eligible to be a Student Member of the Corporation. Student Members are entitled to one vote.

Part VI Line 7a -- Voting Members of the Corporation as described above have the right to elect officers and directors of the corporation, to

approve annual budgets proposed by the Board of Directors, and to act on questions presented by the Board of Directors or by Members of
