Accordingly, there is no provision for federal income taxes in the Foundations financial statements, as the Foundation believes all tax positions, including its continuing status as a not-for-profit entity, have a greater than 50% chance of realization in the event of an IRS audit. With few exceptions, the foundation is no longer subject to U S federal income tax examinations by tax authorities for years before 2013.
