The King's Daughters Health Foundation was formed in 1984 to encourage, hold and administer gifts to the Medical Center. The foundation's board is a network of educators, business leaders, healthcare providers, community members and KDMC team members working together to be good stewards of the funds received. Examples of recent and ongoing projects of the Health Foundation include oversight and distribution of nine scholarships to local high school students, Oncology Center of Excellence expansion to 12,000 square feet, which included adding space for our new breast fellowship trained surgeon that joined the center in the fall of 2017. A Board member who has a conflict of interest must abstain from any relevant discussion or vote. If a conflict of interest is discovered after the fact, the CEO and Vice President, together with the General Counsel, if appropriate, reviews the instance in which the conflict occurred. Those leaders ensure that the conflicted individual did not influence decision-making or profit from the conflict. The conflicted individual is removed from any further involvement.
