Family Care Network provides a compreshensive series of 14 weeks program for the parents who live in Wayne County, Michigan. These classes are in-home or group program. The program address children management skills, effective parenting strategies, age-appropriate expecations and a nurturing home environment. These families are referred from the Department of Hiuman Srvcies or the Court System.

During the short fiscal year of July 1, 2017 to September 30, 2017 approximately 201 families were served.
