The organization provides counseling to pregnant women regarding prenatal and parenting issues to assist mothers in making the best decisions for their children. The organization assists birth mothers with medical costs, transportation to and from medical appointments, food, toiletries, and other living expenses. For birth mothers who choose adoption, the organization places the adoptive children in safe, stable, and loving homes. The organization receives adoption fees from adoptive parents, including application fees, home study fees, and placement fees. For birth mothers who choose to raise their babies, the organization provides them with counseling and connects them to other community agencies that may provide assistance. For the tax year ending September 30, 2017, the organization received calls from 21 pregnant women, worked with and provided assistance for 12 women, and placed 5 babies for adoption.

The organization conducts educational/awareness programs to promote adoption awareness and to educate pregnant women about their options. This includes educational programs for pregnant women, presentations to community groups, and advertising campaigns to publicize the option and benefits of adoption to the general public. Costs include materials that the organization prepares and distributes as well as costs associated with the advertising campaigns, including billboard, publication, and social media advertising costs.
