All board members and employees are required to complete the "Annual Conflict of Interest Disclosure Statement for Directors" form. Questions or concerns are to be directed to the Executive Director or the Chairman of the board of directors. Affidavits and other information is reviewed and the executive director and chairman take appropriate action depending upon the seriousness of the conflict of interest, which may include meeting with the individual, immediate discharge or asking the individual to remove himself from the conflict of interest situation. The procedure is outlined in full detail in the MBC Policy and Procedures Manual.
