FORM 990 ez, LINE L, PART I: I am requesting a special dispensation concerning the use of 990 or 990ez. As shown by the figures on this report, the usual income for BARNABAS is \$100,000, or less. During the fiscal year, '16-'17, we worked with the idea that the income would be approximately the same, but we received \$320,000. from a trust--in September at the end of the fiscal year. So it is, that we did not do the activities, etc. that are on Form 990. BARNABAS is a small organization functioning for the good of our group of churches in Mexico.
