Special events provide a much needed social network for families to benefit socially, psychologically, and emotionally from gathering informally with other children and families who uniquely understand the challenges and long-term effects of a childhood cancer diagnosis. Approximately 2/3 of children will face some degree of latent effects from the treatments they receive.

Programs Special programs enhance the lives of cancer patients and their families through various avenues. Our programs address the needs of a diverse set of our population that include teens, siblings, bereaved families, and volunteers from all ethnic and socio-economic backgrounds.
