ARCTIC LOGISTICS AND COMMUNITY SCIENCE PLANNING: These activities coordinate science planning across disciplinary, organizational, sector, cultural, and geographic boundaries in support of the Arctic research community. ARCUS uses partnerships, workshops, committee activities, and online communications to bring together the Arctic research community, along with its funders and stakeholders. ARCUS is the Project Office for the Study of Environmental Arctic Change (SEARCH), which focuses on advancing cross-cutting research priorities to understand the changing Arctic and engage with key stakeholders. ARCUS works with the U.S. Interagency Arctic Research Policy Committee, providing operational and strategic-level support and bringing research community perspectives to inform the U.S. government's Arctic Research Plan. ARCUS provides project management support, facilitation, administrative, logistical, and travel support and maintains a comprehensive website and publication archives to communicate these activities.

OUTREACH AND INFORMATION: ARCUS supports communication across boundaries by providing valuable information about the wide range of Arctic research efforts to the research community, to other stakeholders, and to the public through online tools, publications, and in-person and virtual meetings. ARCUS provides the venue where Arctic research connects, online at www.arcus.org and in person. Key activities include the Arctic Research D.C. Seminar/Webinar Series, the ArcticInfo email list, the comprehensive global Directory of Arctic Researchers and Calendar of Arctic Research Events, the Witness the Arctic and Witness: Community Highlights Newsletters, and a Conducting Research with Northern Communities web resource. ARCUS also builds connections through individual and small-group conversations. In the education arena, the PolarTREC program supports the development of outstanding education leaders by placing and supporting them to become part of a Polar research team. The Arctic in the Classroom connects rural Alaska teachers with researchers working in their communities to engage students and residents in the research projects that affect them. The Sea Ice for Walrus Outlook is a collaboration between coastal Arctic Alaska communities, the National Weather Service, and other scientists to provide forecasts and on-the-ground information about local conditions to enable safe subsistence activities.

CORE SUPPORT: This is funding of program activities that simultaneously support multiple projects. Core support includes the technological, member community, and management infrastructure of the Consortium. This infrastructure connects groups and individual projects that advance Arctic research. Since ARCUS focuses on system-based approaches to connecting Arctic research across boundaries, many operations cut across multiple program areas. ARCUS, together with a broad range of stakeholders, develops and implements activities that enable communication, coordination, and collaboration across disciplinary, organizational, sector, cultural, and geographic boundaries to plan and implement diverse research and research support efforts.
