HUMANITARIAN ASSISTANCE PCI currently operates disaster risk reduction and humanitarian assistance programs in several countries across Africa, Asia and the Americas. PCI provides humanitarian assistance to people affected by disasters and complex emergencies, helps governments, local organizations, and communities better manage risk and respond to emergencies when they arise, and integrates efforts to help reduce vulnerability to disasters into all its ongoing programs. In Ethiopia, pastoralist families utilized geoclimatic satellite data for decision-making on where to locate good grazing land to reduce livestock deaths. PCI's interventions led to a 47% drop in herd mortality in vulnerable communities representing \$8.4 million dollars in livestock surviving compared to average annual losses experienced in the previous three years. PCI estimates that \$5.4 million (64% of the value in reduced losses) can be attributed to PCI's interventions. This innovative method has been adapted to a mobile platform, and is preparing for scale across Ethiopia, Kenya and Tanzania. Through USAID's REVIVE project in Ethiopia, PCI is increasing vulnerable communities' long-term resiliency to climate-change and climate-related shocks by improving Disaster Risk Reduction decision making, improving household adaptability, and enhancing community planning and processes, which will serve 620,000 people. Under the USAID-funded Barrio Mio Project in Guatemala, PCI is transforming an urban neighborhood by reducing its risk of disaster, strengthening the capacity of its municipal government to manage growth, improving water and sanitation infrastructure, and developing the economic assets of its most vulnerable households. Under Barrio Mio, PCI has reached over 150,000 beneficiaries, upgraded 94 communities, trained over 6,000 people, and engaged with over 40 local partners. Additionally, PCI partnered with AmeriCares to respond to the hurricanes in the United States in the fall of 2017. PCI provided mental health trainings to aid workers, and built the capacity of local organizations to respond to disasters.

FOOD SECURITY PCI takes a comprehensive approach to improving health outcomes by integrating its food security programs with nutrition, health, agricultural development, food aid, and disaster risk management interventions. PCI has implemented 20 USAID Title II food assistance projects since 1997, and is currently implementing projects in Malawi and Guatemala. Through the Njira program in Malawi, PCI is working to build pathways to sustainable food security in the Balaka and Machinga districts. PCI has overall responsibility for Njira's program management, technical leadership, implementation, project monitoring and evaluation, coordination with partner organizations, commodity management, and reporting to USAID. As an implementing partner on the USAID-funded PAISANO program in Guatemala, PCI is leading all project interventions in five of the project's 13 target municipalities, managing distribution of over one-third of the project's commodities, and spearheading the project's cross-cutting goal to improve the status of women. In Guatemala, the USAID-funded ACCION project is reducing hunger and improving nutrition for over 2,700 families through food distribution and vouchers. The program also links public health services to the community, and has reached over 7,000 people through health and nutrition fairs. Through funding from USDA, PCI has designed and implemented an additional 25 food aid projects in Tanzania, Indonesia, Bolivia, El Salvador, Guatemala, Honduras, Mexico, Nicaragua, and the Central American region. PCI is currently implementing three USDA food programs in Tanzania, Guatemala, and Nicaragua. Through USDA-funded school-based food security programs in Nicaragua, Guatemala and Tanzania, over 250,000 students received a hot, nutritious meal daily in 2017. Additionally, PCI is leading a USDA project in Tanzania to procure locally grown food to support additional school feeding programs.

DISEASE PREVENTION As a recognized leader in the use of local programmatic platforms (uniformed services, schools, self-help groups, Care Groups, etc) in order to reach the most vulnerable populations, PCI has used innovative advocacy, communication, social mobilization and behavior change strategies to prevent and mitigate the spread of infectious diseases (such as polio, TB, Ebola, and HIV/AIDS) and chronic diseases (such as heart disease, diabetes and cancer) PCI has been active in the HIV/AIDS response since the early 1990s, and its current portfolio spans the range of prevention, care and treatment interventions in several countries PCI has implemented or is currently implementing 15 major HIV/AIDS-related programs funded by PEPFAR through several USG agencies (CDC, DoD, USAID, and DHHS), and in collaboration with hundreds of local, national and international organizations and partner agencies PCI's overarching approach to HIV/AIDS programming is to leverage its community-based platform across different technical areas as an entry point to promoting effective approaches and improving service uptake In Botswana, with funding from USAID, PCI is connecting orphans and vulnerable children and their caregivers to life-saving HIV/AIDS related services PCI provides sub grants and technical support to six organizations across seven districts to strengthen community agency to seek, support and provide HIV/AIDS services Additionally, as part of this portfolio and with funding from the US Department of Defense, PCI provides technical assistance to the defense forces of Zambia and Malawi to implement, manage, and evaluate comprehensive HIV/AIDS prevention, treatment, and care and support groups In addition, cervical cancer screenings are provided Through PCI's collaboration with the US DOD in these countries, PCI has reached over 100,000 service members and their families since 2003 Working in partnership with the CORE Secretariat in India, the Government of India, The World Health organization, numerous other international and national NGOs, and local district authorities and communities, PCI implements the Core Group Polio Project in 3 high risk districts in the state of Uttar Pradesh Through PCI's social mobilization efforts in Uttar Pradesh, India increased the number of children fully immunized against polio in PCI's intervention areas from only 45.3% in 2010-11 to 73% in 2013 India was declared polio free in 2014, following three years without a single case The Core Group Polio Project (CGPP), implemented by PCI in collaboration with other partners, has played an important role in this success

Form 990, Part III, Line 4c:

MATERNAL AND CHILD HEALTH AND WATER/SANITATION PROJECTS A hallmark of PCI's work is the organization's commitment to implement community-based, holistic, integrated programs that are person centered and recognize the interrelated nature of the issues people and communities face. For example, Women Empowered (WE) is a PCI global initiative dedicated to promoting the economic and social empowerment of women through the formation of self-managed and self-sustaining savings groups. Global membership now totals over 119,694 groups with 1,396,548 members in 13 countries. In recognition of the critical role that women can play as agents of change in the health of their families, PCI's programs related to maternal and child health integrate education on water and sanitation and disease prevention. This is reflected in PCI's Bill and Melinda Gates Foundation-sponsored work in Bihar, India, where 1,219,908 WE members are transforming their families' health by adopting key sanitation behaviors such as hand washing, early and exclusive breastfeeding of infants, and the intake of iron and folic acid for pregnant mothers, as learned through self-help groups. PCI recognizes the impact and importance of mental health on families and communities, and in the US, PCI developed tailored curricula that improved by 40-55% the mental health of vulnerable pregnant women, new mothers, and women of reproductive age participating in support groups. PCI also leads the USAID Every Premie SCALE initiative, a program designed to support practical, catalytic, and scalable approaches to expand the uptake of preterm birth and low weight birth interventions in 23 countries throughout Asia and Africa. Every Premie is supporting implementation and learning research in four countries (Bangladesh, Ethiopia, India and Malawi) and convenes key global working groups to promote global learning, knowledge and collective experience with leading global professional stakeholders. With support from the Eleanor Crook Foundation and the Hilton Foundation, PCI's EFFECT project is researching the effects on child nutrition and development outcomes of engaging men in an infant and young child feeding (IYCF) intervention in Tanzania. Additionally, the project supports the adoption of nurturing practices between caregiver and child, and will target the enabling environment and well-being of caregivers by fostering social cohesion among group members, strengthening the quality of caregiver's relationships, enhancing maternal and paternal mental health, and promoting a safe home environment. A testimony to PCI's long term commitment to the communities it serves, PCI's four legacy programs in India, Guatemala, Mexico and the US/Mexico border have been operating for a combined 68 years, during which time they have served nearly 1.5 million people with lifesaving access to care and services, including safe pregnancy care for Mayan women in Guatemala, access to health assessments and referrals for Mexican immigrants in the US, well-baby clinics in remote urban settlements around Tijuana, Mexico, and support services for street children in New Delhi, India. Finally, PCI has many decades of experience in not only effectively engaging with local entities as partners in transformational development, but also in improving local capacity for sustainable, community-driven change at scale.
