THE TRUSTEE ADVISED THE FOUNDATION THAT THE PROPERTY CONTINUED TO BE OWNED BY AN ENTITY CONTROLLED BY THE LEAD BENEFICIARY. THE CRT REQUIRED THAT ANNUAL DISTRIBUTIONS EQUAL TO 6.7% OF THE INITIAL VALUE OF THE CRT'S ASSETS BE MADE TO THE LEAD BENEFICIARY AND, UPON HER DEATH, THAT ANY REMAINING ASSETS BE DISTRIBUTED TO THE FOUNDATION. DURING THE YEAR ENDED SEPTEMBER 30, 2015, THE TRUSTEE ADVISED THE FOUNDATION THAT THE PROPERTY NEEDED A SHORT-TERM INFUSION OF CASH IN ORDER TO BE MAINTAINED AS SECURITY FOR THE CRT NOTE. THE CRT WAS CASH POOR AT THAT POINT IN TIME. UPON THE TRUSTEE'S RECOMMENDATION, THE FOUNDATION LOANED \$455,619 TO THE CRT. IN TURN, THE CRT LOANED THE FUNDS TO THE ENTITY WHICH OWNED THE PROPERTY WHICH APPLIED THE FUNDS TO THE MAINTENANCE OF THE PROPERTY. IN DECEMBER OF 2015, THE CRT REPAID THE BALANCE OF THIS LOAN TO THE FOUNDATION. IN OCTOBER OF 2016, THE TRUSTEE ADVISED THE FOUNDATION THAT THE LEAD BENEFICIARY WAS GRAVELY ILL AND THAT THE CRT LACKED SUFFICIENT LIQUIDITY TO MAKE ITS REQUIRED ANNUAL ASSET DISTRIBUTION TO HER BASED ON THIS REPRESENTATION, AND IN ORDER TO PRESERVE ITS RIGHT TO RECEIVE THE BALANCE OF THE CRT ASSETS UPON THE LEAD BENEFICIARY'S DEATH, THE FOUNDATION PURCHASED THE CRT NOTE FROM THE CRT FOR ITS THEN AGGREGATE VALUE OF \$487,093 (REPRESENTING THE PRINCIPAL OF \$200,000 AND \$287,093 IN ACCUMULATED INTEREST). THE CRT NOTE HAD A MATURITY DATE OF OCTOBER 1, 2017, CARRIED INTEREST AT 8.75% AND WAS UNDERSTOOD TO BE SECURED AGAINST THE PROPERTY. ON JANUARY 31, 2017, THE LEAD BENEFICIARY DIED, AND THE FOUNDATION INITIATED THE PROCESS TO RECOVER THE DISTRIBUTION OF THE REMAINING ASSETS OF THE CRT. ON MAY 1, 2017, THE TRUSTEE DIED. SHORTLY THEREAFTER, THE FOUNDATION LEARNED THAT THE TRUSTEE HAD MISLED IT WITH RESPECT TO THE OPERATIONS AND ASSETS OF THE CRT AND THE OWNERSHIP AND ADMINISTRATION OF THE PROPERTY FOR MANY YEARS. UPON A REVIEW OF THE TRUSTEE'S RECORDS, THE FOUNDATION DISCOVERED THAT THE CRT HELD NO ASSETS AT THE TIME OF THE DEATH OF THE TRUSTEE BECAUSE FUNDS HAD BEEN DIVERTED FROM THE CRT TO THE TRUSTEE IN HIS INDIVIDUAL CAPACITY.
