The treasurer resigned and was fired by the officers at an emergency
meeting of officers held on August 21, 2018. The treasurer was
arrested on Friday, August 24, 2018 by the Kennebec County Sheriff's
Office and charged with a class B felony which indicates that more than
\$10,000 was stolen and carries a maximum 10 year prison term under
Maine law.
