PAUL AND DOWNTOWN MINNEAPOLIS AND IS A LARGE URBAN AREA. THE CLUB OPERATES A STAND AT THE MINNESOTA STATE FAIR, WHICH RUNS 12 DAYS EACH SUMMER THROUGH LABOR DAY. THE STAND IS RUN BY UNPAID VOLUNTEERS AND SELLS SWEET ROLLS, DONUTS, HOT DOGS, HAMBURGERS, BEER, BRATWURSTS, HOT ITALIAN PORK SANDWICHES, AND SOFT DRINKS. AFTER EXPENSES OF OPERATING THE STAND ARE PAID, ALL PROCEEDS ARE DISTRIBUTED THROUGHOUT THE YEAR TO NEIGHBORHOOD YOUTH GROUPS, MAINLY FOR SPORTS EQUIPMENT, SPORTS ACTIVITIES, AND OTHER YOUTH ACTIVITIES.
