During 2017, the educational sponsorship program increased to more than 9,000 children from grades 1 to university. More than 270 students are attending university and post-secondary vocational school. More than 700 women have been equipped through vocational training and spiritual discipleship, with a class of 85 in 2017. Sponsors gave gifts to children and their families through the online store. Nurses continue to work with children across our six communities with more than 7,300 health visits over the past year. The Africa College of Theology enrolled 576 students, pastors, and ministry leaders. Construction of the \$6.5 million Dream Medical Center was completed with plans to begin offering services in spring 2018.
