The President writes a self-assessment, which is based on the GHC strategic plan, and submits it to a committee of the Board. The Vice Chair of the Board receives that report and discusses it with his/her fellow committee members, as well as the President. At the fall meeting of the Board, in executive session, the committee makes a recommendation to the Board regarding compensation, which the Board adopts. The Federation of State Humanities Councils publishes a salary survey annually, which the Board considers as part of its determination of executive compensation. Other factors include Emory University compensation policies, as the GHC is an affiliate of Emory. The staff members of the GHC also complete annual self-assessments and their performance is reviewed by President. The performance review process of the staff is part of GHC's affiliation with Emory University and it conforms to their Human Resource practices. As the President determines salaries for the staff, he also refers to the Federation of State Humanities Councils' annual survey as well as Emory University's classification system and consideration of market conditions.
