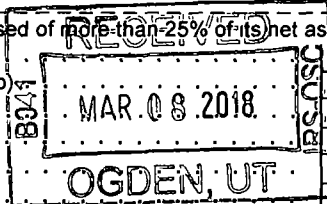

This entity also reconciles the organization's bank statements. The organization pays a fee for these services.
