Honorary members and complimentary members enjoy the same rights and responsibilities as dues paying members, only at the discretion of the board of directors, and are exempt from paying membership dues and fees. Each member has the right to vote. Current annual membership dues are \$20 adult, \$25 family, \$35 sponsor, and \$10 student (18 years and younger). Longer term memberships are available at reduced rates per year. Membership benefits include, but are not limited to: 10 issues of CBRC News newsletter mailed directly each year, discounts for race entry fees to club owned races, discounts offered by local merchants, entrance to free Winter Meeting series, free Bix at Six training runs each summer, free track workouts, entrance to the Annual Club Picnic, participation in children's running programs/events, ability to apply for membership in Cornbelt Racing Team, receipt by mail, quarterly, of Club Running magazine which is a benefit of our club's membership in Road Runners Club of America, organized training runs, and contributing to the well being of our Quad City community through the exercise and health benefits we provide and promote.
