OUR LAND DONATION PROGRAM NOW IT IT'S 11TH YEAR HAS SUCCEEDED IN ACQUIRING SOME 886 PARCELS IN 14 COUNTIES OF MORE THAN 900 ACRES. MOST OF THESE SERVE AS NEIGHBORHOOD NATURE PARKS AND ASSISTING TO HELP CREATE LARGER CONSERVATION AREAS WITH STRATEGIC PURCHASES AND TRADES. PLC HAS BEEN WORKING HARD TO PROTECT PARTS OF THE FLORIDA WILD LIFE CORRIDOR, WHICH STRETCH FROM THE EVERGLADES TO THE OKEFENOKEE SWAMP.
