CARIBBEAN BIRDING TRAIL - THE CARIBBEAN BIRDING TRAIL WAS DEVELOPED TO RAISE GLOBAL AWARENESS OF THE UNIQUE BIRDS AND BIODIVERSITY OF THE CARIBBEAN AND TO CREATE A SUSTAINABLE ECONOMY AROUND RARE SPECIES, IN AN EFFORT TO PROTECT THEM. THE "TRAIL" IS ACTUALLY A MULTI-FACETED PROGRAM TO TRAIN AND SUPPORT LOCAL TOUR GUIDES AND ENCOURAGE NATURE TOURISM THAT SUPPORTS LOCAL COMMUNITIES BY OUTREACH TO INDIVIDUALS AND INTERNATIONAL TOUR COMPANIES. FESTIVALS - BIRD CONSERVATION IN THE CARIBBEAN RELIES ON THE AWARENESS AND STEWARDSHIP OF LOCAL PEOPLE. TO THIS END, BIRDS CARIBBEAN SUPPORTS THE CELEBRATION OF THE CARIBBEAN ENDEMIC BIRD FESTIVAL (CEBF) IN APRIL AND MAY, AND INTERNATIONAL MIGRATORY BIRD DAY (IMBD) IN SEPTEMBER AND OCTOBER. FINALLY, BIRDS CARIBBEAN HAS A ROBUST SUITE OF FLAGSHIP PROGRAMS TO CONDUCT SCIENCE, CAPACITY-BUILDING, EDUCATION, AND NETWORKING WITH MULTIPLE PARTNERS IN THE CARIBBEAN REGION.
