Also, on an annual basis, a review of the president's performance is conducted. In 2017, a board committee selected by the board chair reviewed the president's performance and made recommendations which were filed with the human resources department. Any salary increase recommended based on the president's performance would need to be consistent with the Hay Guide Chart and be approved by the Finance Committee of the Board of Directors.

The Chief Financial Officer, using the job-size and market salary comparisons consistent with the Hay Guide Chart, establishes salary levels and median salaries for each job range. The relevant supervisor may recommend a salary within the Hay Model range based on the employee's qualifications as well as budget constraints. The CFO presents that information to the Finance Committee of the Board of Directors for its review. Ultimately, the Finance Committee's recommendations must be approved by the full board.
