YET, JUST AS THE COMMUNITY LOOKS TO US TO PROVIDE FINANCIAL SUPPORT IN VARIOUS WAYS, SO TOO DO WE DEPEND UPON THE TRUST AND FAITH THAT OUR DONORS AND OUR COMMUNITY PLACE IN US TO SAFEGUARD THE FOUNDATION'S RESOURCES. EVEN THOUGH THE FOUNDATION WILL STILL BE ABLE TO MEET ITS FINANCIAL COMMITMENTS GOING FORWARD, WE FULLY RECOGNIZE THE DAMAGE THIS EPISODE MAY HAVE ON THE TRUST AND FAITH THAT YOU AND THE COMMUNITY PUT INTO US. TO THAT END, WE HAVE PUT INTO PLACE ADDITIONAL SAFEGUARDS AND CONTROLS OVER THE FOUNDATION'S FINANCES TO ENSURE THAT SOMETHING LIKE THIS NEVER HAPPENS AGAIN.
