All members in good standing and qualified shall be entitled to vote. The Executive Board shall decide the last day to which ballots shall be received, and the date, time and place when the ballots will be counted and this information shall be enclosed with the ballot sent to the members. The Executive Board of IBEW LU 2222 serves as trustee of LU 2222 IBEW Benevolent Fund Trust for as long as they serve on the Executive Board of IBEW LU 2222.

Part VI - Line 7b - The trustees meet on the third Wednesday of each month to approve donations, bills and discuss any other matters brought before the trustees. Minutes are taken at this meeting and read to the membership of IBEW LU 2222 at the monthly union meeting which is held on the first Wednesday of each month.
