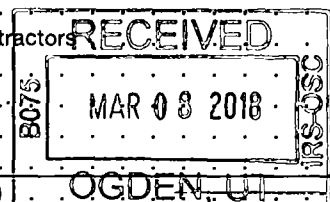



To that end, (1) the grants noted in Part III of Form 990-EZ were distributed; (2) personal work was undertaken by Foresight resource people from the United States: (a) Nepali leaders were trained and supported to develop and expand the operations of a model elementary school, National Bethel Academy, in the town of Trishuli, Nepal through teacher training, organizational development, and financial support; and (b) educational support and vocational guidance was provided to 13 young men and women who have "graduated" from a supportive home run by Prison Fellowship Nepal.

Travel for this work was mostly paid by the expense funds included in line 16 of Part I.
