 It also provides meals to those in the community facing food insecurity.
 Through the Cafe, large scale community meals are hosted each month, during
 our emergency warming centers, during the holiday season and at other
 times when soup kitchens are closed.

 LODGING SERVICES: The Lodging Program provides safe and affordable temporary
 housing to men and women of the sea and those in the community facing
 difficult times, either at no cost or at a greatly reduced rate. If

 with partner agencies to secure appropriate emergency housing.

 BASIC NEEDS SERVICES: This program focuses on basic human needs and addresses
 the neediest in our community and the waterfront. The Institute provides

 and transportation needs and to assist in avoiding heat and light shut-offs.
 The Institutes facility is open 365 days a year to allow access to services,
 especially to those most vulnerable in a seasonal community.
