The Organization awarded \$812,192 in grants to organizations working to promote women's reproductive health and reproductive justice, to develop grassroots criminal justice campaigns to reverse discriminatory practices, to support indigenous communities working for climate justice, to support the organizing hubs fighting to keep immigrant families together, to support community-led rebuilding efforts following Hurricane Harvey in Texas, to support emerging organizations working for racial justice through the Movement for Black Lives, and to sponsor educational outreach for a documuntary film on peace and justice through culture change work in the Middle East. In partnership with Solidaire Network, the Organization also launched a new grantmaking initiative called the Emergent Fund, which awarded rapid-response funding to organizations working to defend vulnerable communities that are under attack by current federal policies and priorities.

Reflective Democracy Campaign The Organization continued its Reflective Democracy Campaign to illuminate and remove the structural barriers to achieving a democracy where our leaders will demographically reflect the American people, including electing more women and people of color. Program accomplishments in 2017 included a comprehensive update of the Campaign's first-of-its-kind database identifying the race and gender of elected officials and candidates on the ballot in the United States, including elected prosecutors. The updated database now also includes the 200 largest cities in addition to the previous federal, state, and county data. The Campaign made this data available to advocates and the general public through a website, video, and infographics in 2017. The Campaign also collaborated with allied funders and grassroots organizations to conduct briefing sessions for advocates in the field, sponsored educational outreach for the documentary film "Councilwoman," engaged in advocacy through strategic messaging, conducted a national online survey of voters' views on reflective democracy issues, and provided support to two Reflective Democracy Innovators who are designing and implementing new approaches to eliminating the structural barriers to a more reflective democracy.
