This was the first time our organization entered into this type of grant process, because of the incubation of Patchwork and Bountiful Cities relationship of incubating this urban farm this particular grant was appropriate fitting the need for expansion. From our experience we would not apply for this funding due to the amount of reporting that is required by our agency without adequate compensation from the grant funds.
