In addition to helping plant and support churches, Global Sharing helped provide funds to help bring Misluna Mondiala Unita leaders to the United States for meetings, support and training.

Continued to support RAY Ministries in their building and operation of an elementary school serving families in Silliguri India. The additional classrooms were completed accommodating 100 additional students. Funds were also granted to support scholarships for some of the students attending the school. In addition to the work with the school, Global Sharing conducted three conferences - two in Silliguri and one in Manipur India. Funds and teaching for all three conferences were provided by Global Sharing. The conferences were: women's conference serving ladies from the local tea fields, pastors/leadership conference for men and women from Northern India/Nepal/Bhutan regions, and; marriage conference for pastors/leaders in the Manipur area.

Funds were used to support Global Sharing's local ministry partner in Northern India. Funds helped to offset the family's living expenses as well as some of their ministry needs. Funds also included the cost associated with bringing our ministry partner to the United States for five weeks for training and sharing of needs/ministry with local churches and individuals.
