Healing Homes Program- LWB continued its successful healing homes program in 2017, accepting children to both our Heartbridge and Anhui Healing Homes from throughout China in need of specialized care for conditions such as prematurity, heart defects, and anal atresia. In addition, LWB began the Mukono Baby Home project in Mukono, Uganda to care for abandoned children born with medical needs such as prematurity and HIV, with a focus on family reunification.
