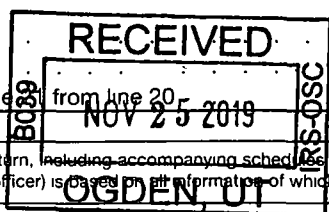

The Maimonides Medical Center Supplemental Executive Retirement Plan for Chief Executive Officer and Executive Vice Presidents (the "CEO & EVP Plan") provides additional retirement benefits to supplement other sources of retirement income. The EVP SERP was effective as of January 1, 2012, and was amended and restated as CEO & EVP Plan as of January 1, 2016, to add the CEO as a participant, and further amended, effective January 1, 2017. To participate, an employee must hold the title of CEO or EVP, be a key employee within the meaning of the Internal Revenue Code and be designated as a participant by the Compensation Committee of the Maimonides Medical Center's Board. The Plan provides for an annual employer accrued contribution of 20% of base salary for that calendar year including interest of 4.5%. The participant must be an eligible employee on the last day of the calendar year to accrue the contribution for that year. With respect to the CEO, the Plan as amended provides for an additional 10% of base salary to be credited with regard to the 2017 Plan year and that the Medical Center's Compensation Committee may approve additional SERP contributions up to 10% of base salary and as determined by the Committee for Plan years after 2017.
