The Board transferred funds from the unrestricted Elizabeth Livingston Estate bequest, along with additional unrestricted funds, into a segregated account, titled the Heckscher Museum General Endowment Fund, to be invested for the long-term. A Board-approved percentage will be drawn from the new quasi-endowment on an annual basis in support of general Museum operations. Access to the corpus of the new endowment, in any amount in excess of the above mentioned Board approved percentage, can only be accessed by the approval of two-thirds (2/3) of the Trustees in order to revoke the restrictions on the use of funds as specified in the resolution. The value of the Heckscher Museum General Endowment Fund on December 31, 2017 was \$3,153,095. Furthermore, at that same meeting on April 11, 2011, the Board of Trustees also passed a formal resolution directing subsequent unrestricted proceeds" of all bequests, charitable remainder trusts, retirement plan beneficiary designations, life insurance beneficiary designations, gift annuities, and other unrestricted deferred transfers to the Heckscher Museum General Endowment Fund. In June 2014, the Board of Trustees authorized the establishment of a quasi-endowment fund with the Town of Huntington Art Acquisition Fund. Under the resolution, the ORIGINAL CORPUS will no longer be used for the purchase of art, but rather it will be a corpus of funds that increases over time and will generate art acquisition revenue to be used at the discretion of the Board for the purchase of art for the Permanent Collection.</p>
