The grantee of the grant of \$395,777 listed in Part II, line 1 is Israel Free Loan Association ("IFLA"). IFLA (now named Ogen-Israel Free Loan Fund) is an Israeli not for profit organization which files reports with, is under the supervision of, and subject to audit by the Registrar of Non-Profit Organizations at the Israel Ministry of Justice and the Non-Profit Division of the Israel Finance Ministry. IFLA is a highly regarded organization with a longstanding history and success rate. Over the last 28 years, IFLA has provided over \$300 million in interest-free loans to low and middle income Israelis and small businesses. With a default rate of less than 0.8%, loans are repaid almost entirely, thus recycling donations to be used for further loans. On average, every dollar donated has been recycled more than 5 times since the organization was founded in 1990. IFLA has issued more than 60,000 loans in total since its inception. The organization helps more than 2,500 individuals, families, and small businesses each year, helping them towards a better financial future in Israel. Of the grant to Israel Free Loan in 2017 \$7,916 was for overhead in connection with interest free loan operations and the balance was for the establishment of or addition to loan funds for interest free loans to low to middle income individuals and families and to small businesses.
