EDUCATION ADEQUATE STATEWIDE EDUCATION FUNDING REMAINS AN IMPORTANT PRIORITY AND SO WHEN A FORMER GOVERNOR BROUGHT A CASE CHALLENGING THE LEGISLATURE'S CHRONIC DISREGARD OF A STATUTORY FUNDING COMMAND, MCJ, WITH PRO BONO SUPPORT FROM O'MELVENY, FILED AN AMICUS BRIEF AND ASSISTED LEAD COUNSEL'S PREPARATION FOR ORAL ARGUMENT BEFORE THE MISSISSIPPI SUPREME COURT AFTER AN ADVERSE RULING, MCJ HAS TURNED ITS FOCUS TO ADEQUATE SCHOOL FACILITIES FUNDING MCJ ALSO JOINED AS CO-COUNSEL IN A CASE CHALLENGING THE PROCESS OF THE STATE DEPARTMENT OF EDUCATION (MDE) TO TAKE OVER THE JACKSON PUBLIC SCHOOL DISTRICT (JPS) ALTHOUGH THE COURT DISMISSED THE ACTION, THE MDE AND JPS SHORTLY AFTERWARD CONVENED A STEERING GROUP THAT AVOIDED AN OUTRIGHT TAKEOVER AND RETAINED A GREATER DEGREE OF LOCAL CONTROL IN VIEW OF A RISE IN BULLYING IN THE CLASSROOM, MCJ REVIEWED ALL SCHOOL HANDBOOKS FOR BULLYING POLICIES, AND DEVELOPED MODEL LANGUAGE TO ENSURE SOME UNIFORMITY STATEWIDE MCJ ALSO TOOK ON A SERIES OF DIRECT SERVICE CASES TO ENSURE STUDENT'S RIGHTS WERE PROTECTED UNDER MOUNTING PRESSURE FROM MCJ'S LITIGATION AND ADVOCACY EFFORTS, THE MISSISSIPPI LEGISLATURE ENACTED STATEWIDE DUE PROCESS POLICIES FOR SCHOOL DISCIPLINE MCJ CONTINUES ITS CASEWORK TO PUSH FOR AN APPROPRIATELY HIGHER STANDARD OF PROOF AND OTHER IMPROVEMENTS MCJ, IN PARTNERSHIP WITH ACLU AND LOCAL PARTNERS UNDERTOOK A PROJECT IN SUNFLOWER COUNTY TO CHANGE EXISTING DISCIPLINE PRACTICES, STRENGTHEN RELATIONSHIPS BETWEEN SCHOOL OFFICIALS, LAW ENFORCEMENT (INCLUDING THE COURTS), AND PARENTS, AND TO CHANGE THE NARRATIVE ABOUT YOUNG MEN OF COLOR THE PROJECT PUT NEW DISCIPLINE POLICIES IN PLACE IN THE SCHOOL HANDBOOK, BUILT TRUST BETWEEN THE STAKEHOLDERS IN DISCIPLINE ISSUES, AND PRODUCED POWERFUL STUDENT-GENERATED MEDIA COLLECTED UNDER THE TITLE ROOTS (RECLAIMING OUR ORIGINS THROUGH STORY) IMPACT LITIGATION PROJECT MCJ'S IMPACT LITIGATION PROJECT, CREATED IN MEMORY OF A FORMER BOARD MEMBER WAS ANNOUNCED IN FEBRUARY 2017 WITH THE ENGAGEMENT OF A PROMINENT CIVIL RIGHTS ATTORNEY TO LEAD THE EFFORT AND ENTRY INTO THE APPEAL OF A CHALLENGE TO MISSISSIPPI'S ANTI-LGBTQ STATUTE, HB 1523 A FIFTH CIRCUIT PANEL REVERSED THE DISTRICT COURT'S INJUNCTION AGAINST THE LAW ON THE BASIS THAT THE PLAINTIFFS LACKED STANDING TO BRING THE ACTION THE FIFTH CIRCUIT, SITTING EN BANC UPHOLD THE PANEL DECISION, AND SO MCJ, WITH SUPPORT FROM EXPERIENCED SUPREME COURT PRACTITIONERS, FILED A PETITION FOR CERTIORARI WITH THE U S SUPREME COURT DESPITE THE REVERSAL, THE CASE BLOCKED THE ENFORCEMENT OF THE LAW FOR OVER A YEAR IN SEPTEMBER, MCJ FILED SUIT AGAINST MISSISSIPPI OFFICIALS ON BEHALF OF EX-FELONS WHO HAVE BEEN DENIED THE RIGHT TO VOTE UPON RE-ENTERING SOCIETY DUE TO A DISENFRANCHISEMENT PROVISION IN THE 1890 MISSISSIPPI CONSTITUTION THE PARTICULAR DISENFRANCHISING CRIMES WERE CHOSEN IN 1890 AS MORE LIKELY TO BE COMMITTED BY BLACKS THAN WHITES, AND MCJ IS SUING BASED ON THE DISCRIMINATORY INTENT AND IMPACT THIS WAS PART OF THE POST-RECONSTRUCTION PLAN OF THE 1890 FRAMERS TO TAKE THE VOTE AWAY FROM AMERICAN-AMERICANS WHILE THE OTHER VOTE SUPPRESSION TOOLS INCLUDED IN THAT CONSTITUTION HAVE BEEN SWEEP AWAY, THIS ONE REMAINS MCJ PARTICIPATED AS CO-COUNSEL IN A SUIT ON BEHALF OF AFRICAN AMERICAN FUNERAL HOMES AGAINST A COUNTY CORONER AND BOARD OF SUPERVISORS THE CLAIM IS THAT THE DEFENDANT CORONER STEERED CERTAIN BUSINESS EXCLUSIVELY TO WHITE FUNERAL HOMES OTHER PROGRAM SERVICE ACCOMPLISHMENTS IN EXPUNGEMENT, AN MCJ ATTORNEY CONDUCTED CLINICS AND REPRESENTED INDIVIDUAL CLIENTS ACROSS THE STATE DESPITE AN INTERRUPTION OF FUNDING MIDWAY THROUGH THE YEAR ON RACIAL JUSTICE AND RECONCILIATION, MCJ WORKED CLOSELY WITH PRO BONO COUNSEL IN WASHINGTON D C AND LOCAL ALLIES TO ADVANCE FEDERAL LEGISLATION THAT WOULD REFER 5 CIVIL RIGHTS SITES FOR POSSIBLE INCLUSION IN THE NATIONAL PARK SERVICE SYSTEM ON DISASTER RECOVERY, MEIJI UNIVERSITY INVITED TWO MCJ ATTORNEYS TO PRESENT REMARKS ON DISASTER RECOVERY AT A CONFERENCE FOR JAPANESE ATTORNEYS FACING CLIENTS AFFECTED BY THE TSUNAMI AND NUCLEAR ACCIDENT MCJ STAFF ALSO PARTICIPATED IN NETWORKS TO ASSIST LEGAL TEAMS RESPONDING TO HURRICANES IN TEXAS, FLORIDA AND PUERTO RICO IN COMMUNITY ENGAGEMENT AND COLLABORATION, MCJ CONTINUED TO HOST AND SERVE AS THE FISCAL AGENT FOR THE SUNFLOWER COUNTY UNITED FOR CHILDREN, A COLLABORATION THAT ADDRESSES COMMUNITY HEALTH, JOB READINESS, AND ENTREPRENEURSHIP
