IN 2017, RISE AGAINST HUNGER REACHED 668,893 PEOPLE EXPERIENCING HUMANITARIAN CRISIS IN 24 COUNTRIES. WE PROVIDED \$6,042,295 IN CRISIS RELIEF ASSISTANCE IN THE FORM OF RISE AGAINST HUNGER MEALS, CASH GRANTS, GIFTS IN KIND AND SUPPORT FOR TRANSPORT, SHIPPING AND HANDLING, PROVIDING LIFE-SAVING ASSISTANCE IN COLLABORATION WITH 21 PARTNERS AND RISE AGAINST HUNGER AFFILIATE LOCATIONS.
