Each year, Baseballtown Charities helps to raise money for other charitable organizations that help underprivileged and disadvantaged youth and their families in Reading and Berks County. This money is raised through gaming with raffles and silent auctions of baseball-related merchandise or memorabilia provided by the Reading Fightin Phils, or through the Toss-A-Ball contest, all raised at the Reading Fightin Phils home games.

These expenses were incurred on behalf of a new program which will be fully in service April 2018. Baseballtown Charities is building the "Dream League" field to give those with physical and mental disabilities the same chance to enjoy the game of baseball as those able-bodied players every day across the country. Traditional baseball fields are not designed for those with special needs. Our Dream League field will be a custom-designed, turf field that accommodates wheelchairs and other assistive devices while helping to prevent injuries. The spirit of the Dream League allows developmentally-challenged children to thrive, without the competitive burdens of traditional teams and leagues. We undertook a fundraising challenge in October 2016 to generate contributions for the building of this special and unique field, and we continued this fundraising challenge in September 2017 to raise additional funds.

This expense is the interest we incurred on a note payable from a 2014 project to help the City of Reading renovate the baseball field at Baer Park.
