Hurricane Harvey Relief and relief work was undertaken in September in Houston and surrounding areas of Houston. Sewa International handled 1577 rescue requests, 687 individuals rescued, 1250 volunteers and over 45000 volunteer hours serving over 30000 hot meals and 21 truck loads of supplies to affected families

Sewa International Houston Chapter received a Grant to do the Case Management of the Hurricane Harvey Victims from the GHCF Grant Committee and started working on the project effective October 15, 2017. The project was expected to be completed by April 15, 2018. Houston Chapter conducts ASPIRE after school tutorial program runs in 3 centers in Alief ISD. Helping 5 schools with over 45 volunteers, 165 tutorials, 205 students with 528 volunteer hours. Family Service Program did Family Crisis Management 53 cases resolved in 10 Sewa Chapters, 51 workshops conducted for Health Awareness, 14 Stop Diabetes Movement workshops conducted in 10 Sewa Chapters in total 13 cities.
