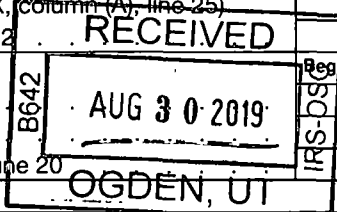

Peruvian Hearts works to end poverty and gender inequality by educating girls and creating a women leaders in Peru. We enable young women in Peru to embrace education, believe in their own power, and dream of and create a better life beyond the conditions into which they were born.

 Peruvian Hearts scholars program provides 40 impoverished girls in Peru with full educational scholarships to attend secondary school, prep academies, and 5 year universities, while also giving our scholars access to mentors, opportunities to participate in community service, regular empowerment classes, and leadership workshops. The girls supported by Peruvian Hearts come from poor families with very limited economic resources and have dealt with extreme hardship. In addition to academic scholarships, Peruvian Hearts scholars receive full medical attention and have access to regular exams while all healthcare costs covered by the organization. We provide our scholars access to a private psychologist, academic tutors, personal and professional mentors, and civic and community leaders. Peruvian Hearts puts a particular emphasis on the personal growth and character development of each of our scholars, in addition to finishing their degrees at university.

 Cusco Medical Mission - This annual medical mission trip, led by a team of doctors from the United States, helps many needy people in Cusco and throughout the communities around the Sacred Valley. This project serves some of the poorest people from the rural communities around Cusco. In the towns of Urubamba and Lamay in the Sacred Valley, more than 600 people can be seen and treated each day by the medical team from the USA. The team also travels to high elevation communities around the Sacred Valley to visit patients that cannot travel to the larger towns in the valley.

 Hogar Mercedes - This children's home provides a loving environment for approximately 14 girls in Izcuchaca, Peru. The hogar supports the girls with their everyday needs such as food, shelter and clothing, in addition to education, access to healthcare and a psychologist. The hogar also supports a nutrition program and provides about 80-100 children from the local community with a daily, nutritious lunch.
