Impact San Antonio endeavors to award at least one \$100,000 grant annually to a nonprofit organization in Bexar County and contiguous counties. Grant applications are accepted for projects or programs in five focus areas: Arts & Culture; Education; Family; Environment, Recreation & Preservation, and Health & Wellness. Separate committees review and evaluate the applications to select finalists. 100% of each member's (or shared member) \$1,000 annual donation is awarded to that year's grant recipients.

In 2017, we awarded 4 - \$100,000 grants and 4 - \$12,000 grants.
